VINCENT DE PAUL HAS OPERATED THE COMMUNITY'S EMERGENCY OVERNIGHT SHELTER FOR ADULTS AND FAMILIES, KNOWN AS ST. VINCENT HOTEL. IN 2008, THROUGH COOPERATION WITH THE OTHER PLACE, THE SHELTER BECAME A TRUE 24-HOUR FACILITY, PROVIDING A SAFE, RESPECTFUL PLACE WHERE PEOPLE CAN MEET WITH CASE MANAGERS AND OTHER AGENCIES, EAT HOT MEALS, AND HAVE THEIR BASIC HUMAN NEEDS MET UNTIL THEY CAN MOVE INTO APPROPRIATE HOUSING.

VINCENT DE PAUL'S TRANSITIONAL HOUSING PROGRAMS PROVIDE A RESIDENTIAL SUPPORT SYSTEM FOR UP TO TWO YEARS FOR PERSONS WHO ARE DRUG AND ALCOHOL-FREE AND COMMITTED TO BECOMING SELF-SUFFICIENT AND ATTAINING PERMANENT HOUSING. THE ST. VINCENT DE PAUL TRANSITIONAL HOUSING FOR WOMEN AND FAMILIES IS LOCATED AT SCATTERED SITES IN THE COMMUNITY, WHILE SINGLE MEN ARE HOUSED AT THE DE PAUL CENTER IN DOWNTOWN DAYTON. ALL ST. VINCENT DE PAUL CLIENTS IN THIS TYPE OF HOUSING RECEIVE CASE MANAGEMENT SERVICES INCLUDING DEVELOPMENT OF AN ACTION PLAN AND ASSISTANCE IN LOCATING SAFE AND AFFORDABLE PRERMANENT HOUSING.

VINCENT DE PAUL FACE A GREATER NUMBER OF CHALLENGES AND WILL NEED LONG-TERM SUPPORT TO MAINTAIN HOUSING STABILITY. OUR PERMANENT SUPPORTIVE HOUSING PROGRAMS HELP TO REDUCE THE RISK THAT THESE CLIENTS WILL END UP BACK IN THE SHELTER SYSTEM. KETTERING COMMONS IS HOME TO 14 FORMERLY HOMELESS FAMILIES WITH SPECIAL NEEDS, WHILE THE SAFE HAVEN PROGRAM PROVIDES PERMANENT HOUSING FOR SINGLE MEN WITH MENTAL HEALTH DIAGNOSIS WHO HAVE BEEN CHRONICALLY HOMELESS. BOTH PROGRAMS PROVIDE ON SITE INDIVIDUALIZED CASE MANAGEMENT AS WELL AS LINKAGE TO OTHER COMMUNITY BASED PROGRAMS AND SERVICES.
